The Regular Meeting of the Mayor and Council of the Borough of Runnemede was held on the above date in the meeting room of the Borough Hall, 24 N. Black Horse Pike, Runnemede, NJ. The meeting was called to order at 7:00 PM. The following members were present at roll call: Mayor Betteridge, Council members: Moore, Beatrice, Kappatos, Scaramuzzo. Absent: McCarthy, Kisielewski. Present: CFO/Business Administrator, Richard Wright, Borough Solicitor, Jack Kennedy, Borough Engineer, Steve Bach.

**STATEMENT:** Mayor Betteridge read the notice of this meeting pursuant to the "Open Public Meetings Act."

**APPROVAL OF MINUTES:** A motion was made by Beatrice, seconded by Kisielewski that the minutes of the 10/5/10 meeting be approved as submitted by the clerk. The motion carried.

**REPORT OF CONSTRUCTION CODE OFFICIAL:** A report was read stating that the sum of \$6,604.000 was collected in various building permits and licenses during the month of October, 2010. All fees were turned over to the Borough Treasurer.

**REPORT OF BOROUGH TREASURER:** A report was read indicating deposits on account as of 10/31/10 totaling \$2,836,353.78.

Mayor & Council:

To control the 2011 budget, the MEL and your JIF have successfully negotiated placement of the Public Officials and Employment practices Liability (POL/EPL) insurance program with a new insurance carrier. The effective date of the change will be January 1, 2011.

The carrier has agreed to use the MEL's basic policy form as the coverage platform and has agreed to continue the system of deductible, co pay and premium incentives that the MEL used in 2010. Therefore, if you updated your employment practices risk control program this year, the new carrier will recognize this for the 2011 policy. The elected official's training credit will also continue and the seminars are being scheduled beginning Wednesday, November 17, 3:45 at the League

Once the final selection is made, you will receive complete details including claims handling procedures.

The cost of the new program is included in your JIF's 2011 budget. You do not need to separately budget this item. As indicated above, those cost represents a substantial reduction as compared to what the 2011 budget would have been had the change not been adopted. Future renewals will depend on actual experience and each JIF's record will be evaluated separately.

It is important to continuing urging the legislature enact controls on frivolous claims and excessive legal costs. In particular, the MEL and the JIF's are supporting a package of five bills that will be discussed at the elected official's seminars. Draft resolutions will be distributed.

Therefore, in accordance with the terms of the current MEL POL/EPL policy and applicable laws and regulations of the State of New Jersey, enclosed please find a copy of Notice of Non-Renewal. This Notice is a formality and you will present3ed with the replacement POL/EPL policy in the coming weeks.

**ORDINANCE #10-12**

## NOVEMBER 3, 2010

WHEREAS, the governing body further wishes to prohibit parking of commercial vehicles and trailers in the parking lots of the Runnemede Public Library and the Harry Williams Building and the parking lot and the Borough owned baseball fields;

NOW, THEREFORE, BE IT ORDAINED by Mayor and Council of the Borough of Runnemede, County of Camden, and State of New Jersey, that Chapter 106 Article II, shall be amended to include the following:

### 106-4.2 Parking of Commercial Vehicles and Trailers Prohibited

. No person, firm or corporation shall park any commercial vehicle, bus or tractor, the gross weight of which exceeds sixteen thousand (16,000) pounds with the load or the number of wheels which exceeds six (6) upon any portion of Constitution Avenue, Broadway Avenue and Elm Avenue at any time.

. No person, firm or corporation shall park any commercial trailer upon any portion of Constitution Avenue, Broadway Avenue and Elm Avenue at any time.

. No person, firm or corporation shall park any commercial vehicle, bus or tractor, the gross weight of which exceeds sixteen thousand (16,000) pounds with the load or the number of wheels which exceeds six (6) upon any portion of the property of the Runnemede Public Library, the Harry Williams Building or the Borough owned playing fields located on Broadway and Elm Avenues.

D. No person, firm or corporation shall park any commercial trailer upon any portion of the property of the Runnemede Public Library, the Harry Williams Building or the Borough owned playing fields located on Broadway and Elm Avenues.

BE IT FURTHER ORDAINED, all ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to such inconsistencies; and

BE IT FURTHER ORDAINED, all ordinances or parts of ordinances not inconsistent with this ordinance shall remain in full force and effect; and

BE IT FURTHER ORDAINED, that this Ordinance will take effect after adoption and publication according to law.

It is further determined that said Closed Session and matters to be discussed therein are matters as permitted under the Open Public Meetings Act.






