# RESOLUTION CERTIFYING THAT GOVERNING BODY HAS REVIEWED 2016 AUDIT RECOMMENDATIONS, BOROUGH OF RUNNEMEDE, COUNTY OF CAMDEN, STATE OF NEW JERSEY

WHEREAS, N.J.S.A. 40A:5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions, and

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, as per the regulations of the Local Finance Board, and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board, and

WHEREAS, failure to comply with the promulgations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S.52:27BB-52-to wit:

R.S. 52:27BB-52-"A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

The Halloween curfew was discussed. A resolution supporting changing the name of I-676 to Battleship New Jersey Highway was discussed. A letter thanking Runnemede first responders was reviewed. Resolutions discussed were as follows: authorizing property maintenance liens, canceling interest, opposing new legislation regarding OPMA & OPRA, accepting resignation of Anita Marta, appointment of assistant tax collector/payroll clerk and urging legislature to extend 2% cap on Police & Fire Arbitration Contract Awards. A public hearing for Ordinance #17-11 was also reviewed.

Councilman Farrell updated everyone on Washington Avenue issues including the problems with the gas main which is holding up the completion of the road. Bob also asked about the funding for the traffic light study, when the digital sign would be purchased and whether trees would be replaced which were removed on Washington Avenue.

Councilwoman Passio reported on the upcoming town wide yard sale, the Green Fair and a 5K Run to be held in April.

Mayor Kappatos discussed upcoming 5K Run to be held.

Councilwoman Kelly reported on the HIF and the JIF and read some comments by John Saville. Eleanor also stated that dividends would be the same for this year as last year.

Councilman Ranieri addressed the audit review and the Green Fair. John suggested consolidating the Green Fair with National Night Out due to lack of participation.

Councilman Root reported on the upcoming leafing season as well as grass cutting which has been extended due to the warm weather. Mike also reported on the problems with the fountain.

Councilman Laubenstein wanted to know how borough would use money in the recreation line item allocated to the summer recreation program. Mayor Kappatos explained that this money could be transferred to accounts in deficit in November as permitted by statute.

Pubic Works Superintendent Harry Wozunk reported on grass cutting, leafing and the delay in the arrival of new truck until mid-November. Harry also reported on some upcoming projects. Councilman Ranieri asked Mr. Wozunk when the pole in the parking lot where the butterfly garden would be placed would be removed. Harry stated that he was waiting to hear from PSE&G to schedule removal.

Borough Solicitor Len Wood informed everyone that he was preparing the deed for VFW playground property. Len also reminded governing body not to reply to all when emailing.

Borough Engineer Mark Basehore reported that two resolutions would need to be adopted at the October meeting-one for new DOT application and one awarding Elm Avenue & Broadway. Mark reviewed his written report as well as the roads intended to be requested to be reconstructed in the DOT application. Mr. Basehore also reported that the Borough did not receive the Open Space Grant applied for. A discussion ensued about the condition of the VFW playground equipment. Councilman Ranieri presented a report to everyone listing the roads where sliplining has been completed.

Acting CFO/Administrator Robert Law thanked Mayor & Council for the reappointment. Bob spoke about the bond anticipation note sale in November. Councilwoman Kelly asked about funding for replacing older fire equipment. Mayor Kappatos stated that would be considered in 2019 as part of our capital budget.

#### GOOD & WELFARE:

Seeing no one wishing to speak, a motion was made by Root, seconded by Laubenstein to close the good and welfare portion of the meeting. The motion carried and Mayor Kappatos declared the good and welfare portion closed.
