

**ORDINANCE #17-12**

**AN ORDINANCE ESTABLISHING THE POSITION OF  
ASSISTANT MUNICIPAL TAX COLLECTOR & PAYROLL CLERK  
IN THE BOROUGH OF RUNNEMEDE  
COUNTY OF CAMDEN, STATE OF NEW JERSEY**

WHEREAS, N.J.S.A. 40A:4-18 allows the governing body to establish certain positions within the municipal police department;

WHEREAS, presently there is no Assistant Municipal Tax Collector & Payroll Clerk;  
and

WHEREAS, Mayor and Council wish to create within the Borough the position of Assistant Municipal Tax Collector & Payroll Clerk; and

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Runnemede, County of Camden, State of New Jersey, that the position of Assistant Municipal Tax Collector & Payroll Clerk is hereby established within the Borough;

BE IT FURTHER ORDAINED that the duties of such Assistant Municipal Tax Collector & Payroll Clerk Position are outlined under the rules and regulations under the New Jersey Civil Service Commission. Those duties include but are not limited to:

- A. Assisting in the administration of the tax collectors office and other related duties;
- B. Payroll Clerk shall perform all payroll services, prepare all necessary payroll reports, and shall report to the tax collector and the CFO, the Administrator or Clerk as determined by the Municipality.

BE IT FURTHER ORDAINED that the duties of such Assistant Municipal Tax Collector & Payroll Clerk Position shall require that the individual possess the following to hold the position:

- A. Graduation from an accredited college or university with a Bachelor's degree if the applicants do not meet the above educational requirement they may substitute two years of fulltime experience in municipal tax collection.
- B. Appropriate knowledge and ability as outlined in the Civil Service description.


Chapter 193: Games of Chance  
Article III Raffle and Bingo Licensing


The Municipal Clerk is hereby authorized and delegated the authority to approve the granting of raffle and bingo licenses to be held in the Borough of Runnemede.

The Clerk shall report a detailed listing of all raffle and/or bingo licenses authorized by the Clerk at the next regularly scheduled meeting of Mayor and Council.





**ORDINANCE #17-15**

**AN ORDINANCE AMENDING SECTION 395-15 (ZONING/FENCES, HEDGES AND WALLS) OF THE CODE OF THE BOROUGH OF RUNNEMEDE**

**WHEREAS**, Chapter 395 of the Code of the Borough of Runnemede is entitled Zoning and contains certain definitions, regulations, and requirements; and

**WHEREAS**, the Mayor and Council of the Borough of Runnemede have determined that Section 395-15 of the Code needs to be changed; and


**WHEREAS**, the Mayor and Council of the Borough of Runnemede have determined that it is in the best interest of the Borough and its taxpayers to amend this section of the Code; and

**NOW, THEREFORE, BE IT ORDAINED** by the governing body of the Borough of Runnemede, County of Camden, State of New Jersey, that Section 395-15A(5) shall be amended as follows:

No person shall erect a fence with a height of six feet or less without first obtaining a permit from the Zoning Officer. Any person wishing to erect a fence of six feet or less shall be required to submit a survey with their zoning application. Fences placed adjacent to the sidewalk shall be installed no closer than two feet from the edge of the sidewalk. A zoning permit shall be required whether a fence is installed in a new location or replacing an existing fence, replacing an existing fence shall be defined as replacing more than 25% of an existing fence within any twelve (12) month period. The costs of the application and zoning permit shall total \$65.00.





THE CODE OF THE BOROUGH OF RUNNEMEDE**






