§ 106-1

ARTICLE I **Terminology**

§ 106-1. Definitions.

Whenever any words and phrases are used in this chapter, the meaning ascribed to them respectively in Subtitle 1 of Title 39 of the Revised Statutes of New Jersey shall be deemed to apply to such words and phrases used herein.

ARTICLE II **Parking**

§ 106-2. Regulations not exclusive.

The provisions of this article imposing a time limit on parking shall not relieve any person of the duty to observe other and more restrictive provisions prohibiting or limiting the stopping, standing or parking of vehicles as set forth in N.J.S.A. 39:4-138 or in any other New Jersey statute, or as hereinafter provided.

§ 106-3. Prohibited parking on certain streets.

No person shall park a vehicle at any time upon any of the streets or parts thereof described in Schedule I, § 106-15, attached hereto and made a part of this chapter.

§ 106-4. Parking prohibited during certain hours.

No person shall park a vehicle between the hours specified in Schedule II, § 106-16, of any day, from Monday to Friday inclusive, upon any of the streets or parts of any streets described in Schedule II attached hereto and made a part of this chapter.

§ 106-4.1. Overnight parking on streets. [Added 5-3-1994 by Ord. No. 94-4; amended 7-1-2008 by Ord. No. 08-11; 10-7-2008 by Ord. No. 08-18]

A. Definitions. As used in this section, the following terms shall have the following meanings:

COMMERCIAL TRAILER — Any trailer to be pulled by tractor truck, truck or motor vehicle which extends six feet, regardless of weight. Specifically excluded from this definition are boats, utility and travel trailers and campers.

COMMERCIAL VEHICLE — Any motor vehicle which is required by law to bear any license plate, other than that issued for a passenger car, which, by reason of a characteristic color or marking, exceeding one square foot in area, is identified or commonly associated with any business, industry or public agency, shall be considered a commercial vehicle within the terms of this chapter.

DETACHABLE TRAILER — A vehicle of any size or shape, on wheels or other means of support, capable of being transported upon the streets by attachment to a motor vehicle or by the application of some other separate independent power source. Specifically included in this definition are boats, utility and travel trailers and campers.

TRAILER — Any vehicle used or constructed to be used as a conveyance upon public streets, whether self-propelled or otherwise, and so designed as to permit the occupancy thereof as a dwelling or sleeping place; and non-self-propelled vehicles of any kind or character or intended to be moved under fuel power. This shall also include vehicles known as "recreational vehicles," "rec-vees," "motor homes" "caravans" or "trailers."

- B. No person, firm or corporation shall park any commercial vehicle, bus or tractor, the gross weight of which exceeds 16,000 pounds with load or the number of wheels on which exceeds six, upon any street or portions thereof within the Borough of Runnemede, within the hours of 9:00 p.m. and 6:00 a.m. of everyday.
- C. No person, firm or corporation shall park any commercial trailer, trailer or detachable trailer, boat, travel trailer or camper upon any streets or portions thereof within the Borough of Runnemede, within the hours of 9:00 p.m. and 6:00 a.m. of everyday.

D. Nothing within this chapter shall be construed as preventing vehicles of the gross weight exceeding 16,000 pounds from making deliveries of merchandise or property or as prohibiting any vehicles exceeding 16,000 pounds used by any public utility company in connection with the construction, installation, operation or maintenance of any public utility facility from parking while being used for such purposes.

§ 106-4.2. Parking of commercial vehicles and trailers prohibited. [Added 11-3-2010 by Ord. No. 10-12]

- A. No person, firm or corporation shall park any commercial vehicle, bus or tractor, the gross weight of which exceeds sixteen thousand (16,000) pounds with the load or the number of wheels on which exceeds six, upon any portion of Constitution Avenue, Broadway Avenue or Elm Avenue at any time.
- B. No person, firm or corporation shall park any commercial trailer upon any portion of Constitution Avenue, Broadway Avenue and Elm Avenue at any time.
- C. No person, firm or corporation shall park any commercial vehicle, bus or tractor, the gross weight of which exceeds 16,000 pounds with the load or the number of wheels on which exceeds six, upon any portion of the property of the Runnemede Public Library, the Harry Williams Building or the Borough-owned playing fields located on Broadway and Elm Avenues.
- D. No person, firm or corporation shall park any commercial trailer upon any portion of the property of the Runnemede Public Library, the Harry Williams Building or the Borough-owned playing fields located on Broadway and Elm Avenues.

§ 106-5. Limited parking on certain streets.

No person shall park a vehicle for longer than the time limit shown in Schedule III, § 106-17, at any time between the hours listed in said Schedule III of any day, from Monday to Friday inclusive, upon any of the streets or parts of the streets described in Schedule III attached hereto and made a part hereof.

§ 106-5.1. Residential permit parking. [Added 10-5-1993 by Ord. No. 93-6]

- A. Parking by permit only in designated residential areas. No vehicles shall be parked on the streets or parts of streets designated below, made part of this section, during the hours so designated, unless:
 - (1) The vehicle is owned or operated on a regular basis by a resident of that street and the vehicle has displayed a current residential parking permit on its left rear window in such a manner as to be closely examined by an officer; or
 - (2) The vehicle falls under one of the exemptions to the parking ban set forth in Subsection B.
- B. Exemptions. The following vehicles shall be exempt from this parking permit section:
 - (1) Visitors. A vehicle displaying a current visitor parking permit may park a maximum of two days, provided that the operator of a vehicle is a bona fide guest of a resident within the permit parking area. The visitor's permit shall be displayed on the dashboard of the vehicle in such a manner as to be clearly visible by an officer enforcing parking regulations.
 - (2) Contractors, service and delivery vehicles. Contractors, service and delivery vehicles, bearing the name and address of a commercial business may park without a permit during the time they are rendering service to a residence within the permit parking area.

- (3) Emergency vehicles. Emergency vehicles and public service, telephone and other public utility vehicles may park within the permit parking area during the time they are rendering service or repairs within the area.
- C. Administration. Application for parking permits under this section shall be made in writing on forms provided to the Chief of Police or his designee. Permits shall be granted only under the following terms and conditions:
 - (1) To persons who are residents on said street or portion thereof upon which parking is restricted by this section, a permanent permit, valid one year for tenants and three years for owner-occupants, shall be issued for every vehicle owned or principally operated by such person, subject to a limit of four permits for each residential dwelling unit.
 - (2) Visitor permits may be issued for each residential structure to any street or portion thereof upon which parking is restricted by this section for use by visitors to a resident of a residential dwelling unit within such structure. Such visitor permits must be obtained by and issued to the owner of the structure and will be valid for a period of one year in cases of owner-occupied structures and six months in cases of non-owner-occupied structures. Such permits may be issued for succeeding years or months as needed.
- D. Responsibility to traffic rules and regulations. A resident parking permit does not exempt a resident from obeying all traffic rules and regulations, including but not limited to too close to stop signs, intersections and alternate side.
- E. Limited distance. The visiting permits shall be valid within a reasonable distance from the address for which the permit is issued.
- F. Schedule of streets for residential parking permit. The following streets or parts thereof are designated as requiring residential parking permits:

- G. Hours for residential parking permit. In accordance with the provisions of this chapter, no vehicles shall be parked between the hours of 7:00 a.m. and 3:00 p.m. Monday through Friday.
- H. Violations and penalties. Violations and penalties are provided for in § 106-48 of the Code of the Borough of Runnemede.

§ 106-5.2. School employee parking. [Added 6-2-2020 by Ord. No. 20-07]

Borough of Runnemede, NJ

A. Schedule of streets for school employee parking permit. The following streets or parts thereof are designated as requiring school employee parking permits:

B. Permits will be issued by the appropriate school officials and are limited to school employees only.

ARTICLE III One-Way Streets

§ 106-6. One-way streets designated.

The streets or parts of streets described in Schedule IV attached to and made a part of this chapter are hereby designated as "one-way streets" in the direction indicated.

ARTICLE IV

Through Streets; Stop Intersections; Yield Intersections

§ 106-7. Through streets designated.

Pursuant to the provisions of N.J.S.A. 39:4-140, the streets or parts of streets described in Schedule V attached to and made a part of this chapter are hereby designated as "through streets." Stop signs shall be installed on the near right side of each street intersecting the through street except where "Yield Right of Way" signs are provided for in the designations.

§ 106-8. Stop intersections.

Pursuant to the provisions of N.J.S.A. 39:4-140, the intersections described in Schedule VI attached to and made a part of this chapter are hereby designated as "stop intersections." Stop signs shall be installed as provided therein.

§ 106-9. Yield intersections. [Added 8-6-1968 by Ord. No. 226]

Yield intersection shall be designated by "Yield Right of Way" signs.

ARTICLE V **Penalty**

§ 106-10. Violations and penalties.

Unless another penalty is expressly provided by New Jersey statute, every person convicted of violating any provisions of this chapter shall be liable to a penalty of not more than \$50 or to confinement in the county jail for not more than 15 days, or both, in the discretion of the Municipal Court of the Borough of Runnemede.

ARTICLE VI Validity; Title

§ 106-11. Severability.

If any part or parts of this chapter shall for any reason be held to be invalid, such decision shall not affect the validity of the remaining portions of this chapter.

§ 106-12. Repealer.

Any and all ordinances or parts of ordinances in conflict with or inconsistent with the provisions of this chapter are hereby repealed, except that this repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of any ordinances hereby repealed prior to the taking effect of this chapter.

§ 106-13. Short title.

This chapter may be known and cited as the "Traffic Ordinance."

§ 106-14. When effective.

This chapter shall take effect following adoption and publication according to law.

ARTICLE VII Schedules

§ 106-15. Schedule I: Prohibited Parking on Certain Streets.

In accordance with the provisions of § 106-3, no person shall park a vehicle at any time upon any of the following described streets or portions thereof:

§ 106-22. Definitions.

Whenever any words and phrases are used in this article, the meaning ascribed to them respectively is as contained in Subtitle 1 of Title 39 of the Revised Statutes of New Jersey and shall be deemed to apply to such words and phrases as are used herein.

§ 106-23. Through streets designated.

Pursuant to N.J.S.A. 39:4-140, the streets or parts of streets described in Schedule I attached hereto and made a part of this article are hereby designated as through streets. Stop signs shall be installed on the near right side of each street intersecting the through street.

§ 106-24. When effective.

This article shall take effect following its adoption and publication according to law; provided, however, that this article shall not be considered as being of any effect or validity until the Borough of Barrington shall adopt a similar ordinance.

§ 106-25. Schedule I: Through streets designated.

ARTICLE IX

Triton Regional High School Parking [Added 2-5-1963 by Ord. No. 167]

§ 106-26. Parking prohibitions; removal of vehicles in violation.

- A. The parking of motor vehicles is prohibited at all times on the driveways, roadways and loading circle on the property of the Triton Regional High School, situate on Schubert Avenue in the Borough of Runnemede.
- B. The parking of motor vehicles on any other portion of the property of the said Triton Regional High School is prohibited at all times, with the following exceptions:
 - (1) The parking of motor vehicles bearing an appropriate, current permit issued by the Board of Education of the Black Horse Pike Regional School District shall be permitted in those sections of the school property designated as administrative or faculty-student parking areas.
 - (2) The parking of motor vehicles in those sections of the school property designated as visitors' parking areas shall be permitted in the case of all business invitees and other persons having reasonable cause to be on the school premises.
- C. Any unoccupied vehicle parking or standing in violation of § 106-26A and B of this article shall be deemed a nuisance to the safe and proper regulations of traffic, and any peace officer may provide for the removal of such vehicle from the school property, in which event the owner of said vehicle shall pay the reasonable costs of the removal and storage which may result from such removal, before regaining possession of the vehicle.

§ 106-27. Violations and penalties. [Amended 5-3-1994 by Ord. No. 94-4]

- A. Any person, firm or corporation who or which shall violate any provisions of this article shall, upon conviction thereof, be subject to a fine of not more than \$50 or imprisonment for a term not exceeding 15 days, or both.
- B. Any person, firm or corporation who or which shall violate § 106-4.1 of this chapter, upon second or subsequent convictions thereof, shall be subject to a fine of not more than \$100 for a second conviction and not more than \$500 for the third or subsequent conviction or imprisonment for a term not exceeding 15 days, or both.

§ 106-28. Signs to be placed.

Due notice of the provisions of this article shall be given to the public by the placing of signs at the places where the ordinance is effective. Such signs shall conform to the specifications contained in Title 39 of the Revised Statutes of New Jersey.

§ 106-29. Repealer.

All ordinances or parts of ordinances inconsistent with the provisions of this article are hereby repealed, but only to the extent of such inconsistency.

§ 106-30. When effective.

This article shall take effect upon final approval and publication according to law and upon approval by

the Director of the Division of Motor Vehicles of the State of New Jersey.

ARTICLE X Speed Limits [Added 2-2-1971 by Ord. No. 248]

§ 106-31. Speed limits established.

The following speed limits shall be established along the following streets:

- A. Thirty-five miles per hour.
 - (1) Along Evesham Road, County Route 544, in both directions, for a period of one year beginning with the date of approval by the Commissioner of Transportation. [Amended 12-5-1972 by Ord. No. 263]

§ 106-32. Signs to be erected.

Regulatory and warning signs shall be erected and maintained as required by the Commissioner of Transportation.

§ 106-33. Repealer.

All ordinances or parts of ordinances inconsistent with the provisions of this article are hereby repealed as to such inconsistencies only.

ARTICLE XI

Emergency No Parking [Added 11-8-1972 by Ord. No. 262]

§ 106-34. Erection of signs in emergencies.

Upon the declaration of an emergency, there shall be no parking upon streets or sections of streets where temporary emergency no-parking signs are displayed. The Chief of Police, or in his absence the ranking police officer, is authorized to declare an emergency and to direct the posting of said emergency no-parking signs when weather conditions, accidents, fires or public celebrations dictate or require the avoidance of hazards or other conditions which interfere with the free flow of traffic.

§ 106-35. Removal of vehicles.

Any unoccupied vehicle parked or standing in violation of this article shall be deemed a nuisance and a menace to the safe and proper regulation of traffic, and any peace officer may provide for the removal of such vehicle. The owner shall pay the reasonable costs of the removal and storage which may result from such removal, before regaining possession of the vehicle.

§ 106-36. Effectiveness.

The effectiveness of this article is contingent on signs being erected as required by law.

§ 106-37. Violations and penalties.

Unless another penalty is expressly provided by New Jersey statute, every person convicted of a violation of a provision of this article or any supplement thereto shall be liable to a penalty of not more than \$50 or imprisonment for a term not exceeding 15 days, or both.

§ 106-38. When effective.

This article shall become effective upon final passage and publication according to law.

ARTICLE XII Stopping or Standing

[Added 3-4-1975 by Ord. No. 285]

§ 106-39. Definitions.

Whenever any words and phrases are used in this article, the meaning ascribed to them respectively in Subtitle 1 of Title 39 of the Revised Statutes of New Jersey shall be deemed to apply to such words and phrases used herein, particularly with regard to the definition of "stopping or standing" which shall mean any cessation of movement of a vehicle, whether occupied or not, except when necessary to avoid conflict with other traffic or in compliance with the directions of a police officer or traffic control sign or signal.

§ 106-40. No stopping or standing zones.

The following described areas within the Borough of Runnemede are hereby declared no stopping or standing zones, and no person shall stop or stand a vehicle at any time in any of the areas herein described:

§ 106-41. When effective.

ARTICLE XIII

ARTICLE XV

Handicapped Parking [Added 7-2-1991 by Ord. No. 91-04]

§ 106-46. Designation and use of restricted spaces.

All parking spaces designated for use by drivers who are handicapped or physically disabled on public or private property shall be clearly marked with a handicapped parking sign approved by the New Jersey Department of Transportation. All such locations are hereby designated as restricted parking spaces for use by persons who have been issued a special vehicle identification permit by the State of New Jersey Division of Motor Vehicles or any approved permit issued by another state.

§ 106-47. Prohibitions; existing spaces.

All other persons are prohibited from parking in the designated handicapped parking spaces. Existing handicapped parking spaces within the Borough of Runnemede, County of Camden, having been so designated by any authorized officer or agent of the Borough, will be in compliance upon the effective date of this article.

§ 106-48. Violations and penalties.

Unless another penalty is expressly provided for by the State of New Jersey, every person convicted of violating this article shall be subject to a fine of \$100 for the first offense, and for a subsequent offense, a fine of at least \$100 and up to 90 days' community service on such terms and in such form as the court shall deem appropriate, or any combination thereof.

§ 106-49. Repealer.

All ordinances or parts of ordinances inconsistent with this article are hereby repealed.

§ 106-50. When effective.

This article shall become effective 20 days after its passage when published as required by law.

ARTICLE XVI Electric Vehicle Parking [Added 5-4-2021 by Ord. No. 21-04]

§ 106-51. Public parking spaces for charging electric vehicles.

A. As used herein, the following terms shall have the following meanings:

CHARGING STATION — A location that is fitted with charging station equipment.

CHARGING STATION EQUIPMENT — The conductors, including ungrounded and grounded, and the electric vehicle connectors, attachment plugs, and all other fittings, devices, power outlets, charging status or apparatus installed specifically for the purpose of delivering electrical energy from the charging station to the electric vehicle.

CHARGING STATION SPACE — A dedicated, marked parking space that is fitted with charging station equipment and exclusively used for the charging of electric vehicles.

ELECTRIC SCOOTER and/or ELECTRIC MOTORCYCLE — A two-wheel or three-wheel electric vehicle that operates exclusively on electrical energy stored in the vehicle's batteries.

ELECTRIC VEHICLE — A vehicle that operates, either partially or exclusively, on electrical energy from a charging station or other electrical energy source that is stored in the vehicle's battery for propulsion purposes. Electric vehicle includes: a battery electric vehicle; a plug-in hybrid electrical vehicle; a neighborhood electric vehicle; and electric scooters or electric motorcycles.

NEIGHBORHOOD ELECTRIC VEHICLE — An electric vehicle that is a low-speed vehicle, built to have a top speed of 25 miles per hour and have a maximum loaded weight of 3,000 pounds.

NONELECTRIC VEHICLE — A vehicle that does not meet the definition of "electric vehicle" as provided herein.

PLUG-IN HYBRID ELECTRIC VEHICLE or PHEV — An electric vehicle that: contains an internal combustion engine and also allows power to be delivered to drive wheels by an electric motor; charges its battery primarily by connecting to a charging station or other electrical source not on board the vehicle; may additionally be able to sustain a battery charge using an on-board internal-combustion-driven generator; and has the ability to be propelled through the use of electricity.

- B. The municipality has currently designated two parking spaces at the Borough Hall front parking lot. Both spaces are directly in front of the E.V. Dual Port Charging Station.
- C. The following fees shall apply:
 - (1) For up to two hours of charging: \$1.50.
 - (2) For more than two hours of charging: \$2.50 for every hour thereafter.
- D. No parking shall be permitted in these identified charging spaces as signs shall indicate, and all vehicles not charging in these spaces shall be towed, and the vehicle owner shall be responsible for all fees associated with prohibited actions.
- E. Hours of operation are 24 hours a day, seven days a week, however are subject to change as directed by Mayor and Council.
- F. Use of the charging station spaces shall be limited and restricted as follows:

- (1) It shall be unlawful for any person to park or leave a vehicle idling unless the vehicle is an electric vehicle as defined in this section and is connected for electric charging purposes; and
- (2) Electric vehicles are authorized to park in spaces designated as charging station spaces only during the time when the vehicles are connected for electric charging purposes or up to four hours, whichever is less. Within 15 minutes of the time the vehicle is no longer charging, the owner or operator of said vehicle shall be required to remove the vehicle from the charging station space. If the owner or operator of said vehicle allows his or her vehicle to remain in a charging station space while the vehicle is no longer charging past the fifteen-minute grace period, then said owner or operator shall be in violation of this section.

§ 106-52. Violations and penalties.

A. First offense: \$50.

B. Second and third offense: \$100.

C. Fourth to ninth offense: \$200.

D. Tenth or more offenses, per offense: \$300.

ARTICLE XVII Do Not Block The Box [Added 9-6-2022 by Ord. No. 22-11]

§ 106-53. Do not block the box intersections.

No driver shall enter a marked crosswalk or a marked intersection described in Schedule IX (or § 106-21.2), unless there is sufficient space on the other side of the intersection to accommodate the vehicle without obstructing the passage of other vehicles or pedestrians.
