

JULY 2, 2024

The Regular Meeting of the Mayor and Council of the Borough of Runnemede was held on the above date. The meeting was called to order at 7:00 PM. The following members were present at roll call: Mayor Kappatos; Council members: Passio, Kelly, Farrell, Laubenstein & Murray. Absent: Cepero. Borough Solicitor, Daniel Long; Borough Engineer, Mark Basehore & CFO, Shelley Strehle were also present.

STATEMENT: Council President Passio read the notice of this meeting pursuant to the "Open Public Meetings Act."

APPROVAL OF MINUTES: A motion was made by Passio, seconded by Farrell, that the minutes of the 5/28/24 and 6/5/24 meetings be approved as submitted by the clerk. Laubenstein abstained from vote due to absence from each meeting. The motion carried and Council President Passio declared the minutes approved.

PRESENTATIONS:

Mayor and Council presented a retirement plaque to Fire Official, Scott Hill, in honor of his years of service from 1999 to 2024. Mayor Kappatos and Councilwoman Kelly each said a few words and Mr. Hill thanked everyone.

PUBLIC HEARINGS:

ORDINANCE 24-12: AN ORDINANCE OF THE BOROUGH OF RUNNEMEDE, COUNTY OF CAMDEN, NEW JERSEY, APPROPRIATING \$100,000 OF SEWER UTILITY CAPITAL RESERVE FUND FUNDS FOR THE COMPLETION OF A SEWER UTILITY CAPITAL PROJECT IN AND FOR THE BOROUGH

Mayor Kappatos stated that it was now time for the public hearing to be held as it was advertised to be held at this time and declared the meeting open to the public. There appearing no one wishing to speak, a motion was made by Laubenstein, seconded by Passio to close the public portion. The motion carried and Mayor Kappatos declared the public portion closed.

The motion carried and Mayor Kappatos requested a roll call vote with the following results: Ayes: Passio, Kelly, Farrell, Laubenstein & Murray. Nays: None. Absent: Cepero. Mayor Kappatos declared ordinance 24-12 adopted.

ORDINANCE 24-14: AN ORDINANCE AMENDING CHAPTER 321 OF THE CODE OF THE BOROUGH OF RUNNEMEDE ENTITLED "STORMWATER CONTROL" (IMPROPER DISPOSAL OF WASTE)

Mayor Kappatos stated that it was now time for the public hearing to be held as it was advertised to be held at this time and declared the meeting open to the public. There appearing no one wishing to speak, a motion was made by Murray, seconded by Laubenstein to close the public portion. The motion carried and Mayor Kappatos declared the public portion closed.

ORDINANCE 24-15: AN ORDINANCE AMENDING CHAPTER 321 OF THE CODE OF THE BOROUGH OF RUNNEMEDE ENTITLED "STORMWATER CONTROL" (SALT STORAGE)

There appearing no one wishing to speak, a motion was made by Laubenstein, seconded by Passio to close the public portion. The motion carried and Mayor Kappatos declared the public portion closed.

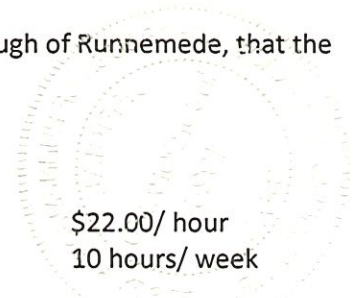

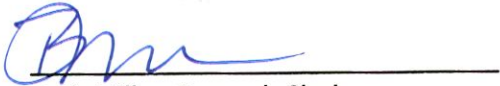
